- ➤ Treasurer Flowers recommended the board have an audit done of the 12/31/2011 balance sheet of the POA. The Board discussed the recommendation. Treasurer Flowers will solicit bids and use the best bid. Subsequent fiscal year audits are required by the Firefly Cove POA by-laws. The recommendation was approved by motion, second, and a unanimous vote 5-0.
- ➤ Secretary Kirkman presented the POA Assessment Waived/COA Reimbursement Agreement to the Board. The Board discussed the agreement. Vice President Voltz suggested that the COA be reimbursed as per the agreement for April 2012 and July 2012 as soon as the agreement was executed by both parties. The recommendation was approved by motion, second, and a passed by a vote of 4-0. Secretary Kirkman did not vote.
- Secretary Kirkman presented the Firefly Property Owners Association Dock/Boat Slip Regulations to the Board. The Board discussed the agreement. The recommendation was approved by motion, second, and passed by a vote Of 4-0. Director Pritchett did not vote.
